### April 16th is National Healthcare Decisions Day

<u>National Healthcare Decisions Day (NHDD)</u> is an annual event that exists to inspire, educate and empower the public and health care providers about the importance of advance care planning.

Advance care planning is the process of thinking, discussing, and ultimately documenting your wishes, values, and preferences for your future care in the event you are unable to speak for yourself. This includes selecting a health care agent to carry out these wishes.

Founded in 2008, NHDD's purpose was to provide clear, concise, and consistent information on healthcare decision-making. Today, NHDD is recognized through a series of independent events held across the country on or around **April 16th**, to bring attention to this important and often

uncomfortable topic.

#### *Empower yourself and your family by Engaging in Conversation around advance care planning.*

According to a recent poll by the Kaiser Family Foundation, only 1/3 of Americans have their wishes documented. Rates are far lower for African American adults over 65, where only 19% have their wishes documented.

In 2018 and 2019, the ACCA participated in NHDD through our"*I Choose to Prepare - Tell Your Story*" community event, that encouraged the discussion of advance care planning preparation in a positive, empowering and joyful manner through music, dance, spoken word, and the other creative expressions from our churches and community.

### ACCA's Care Planning Workbook



#### We are excited about our newly designed Care Planning Workbook!

This advance care planning guide was originally developed in 2019 by the ACCA, specifically for the faith-based African American community. ACCA Leadership, Care Navigators and Pastors were all lead contributors to this effort. In 2020, the Care Planning Workbook received a professional makeover thanks to funding provided through the UC Davis School of Nursing and Research. Dr. Jill Joseph, longtime partner of the ACCA and lead developer for the workbook, was instrumental in securing these necessary funds.

We are so proud to be able to provide this important workbook to our program participants. Our Care Navigators are specially trained to walk participants through the 3 easy-to-follow steps of **Think**, **Plan** and **Do**. Care Navigators help guide participants in thinking through what is important to them, what makes their life meaningful and how they can document those wishes on the included forms. The workbook also features information on what treatments are available at the end-of-life, how to have discussions with family, friends, and their clinicians and how to select a health care agent.

As one of the Five Cornerstones of our Advanced Illness Care Program, Advance Care Planning is an integral part of our work with participants. And the COVID-19 pandemic has helped to bring a greater awareness to our community on the importance of documenting your wishes.

# Nursing Homes, Assisted Living and Senior Housing

We are working closely with health care

systems to pilot a partnership with the ACCA Advanced Illness Care Program and work directly with referred patients.

Thanks to funding by the Stupski Foundation, we are close to launching a 3-year pilot with Kaiser Permanente Oakland. A designated Care Navigator will be working closely with Kaiser patients referred through this pilot to provide services and resources across our Five Cornerstone Holistic Approach to Care.

And for the past year we have worked closely with LifeLong West Berkeley and now AHS Palliative Services through small pilots that we hope to continue to build upon.

Bringing faith, health and community partners to the table will allow us to walk alongside those persons dealing with advanced illness and their devoted Caregivers. The work of the ACCA also extends to Nursing Homes, Assisted Living and Senior Housing facilities. Wherever support is needed for those dealing with advanced illness and Caregiver collaboration we are here to serve.

We work alongside Administrators and Social Workers in facilities to not only provide additional resources and empowerment for residents and family members but also trainings for staff on Caregiver support, Grief and Loss, Advance Care Planning, Palliative Care and other relevant topics.

### ACCA Is Hiring!!

We are currently recruiting for an Assistant Director to support the ongoing program and expansion work of the ACCA.
